### TERMS OF ENROLLMENT

I understand and agree to all of the following Terms of Enrollment:

1. All deposits are fully refundable until January 15, 2012. All payments in excess of the deposit are fully refundable until March 1, 2012. After March 1, Camper's family is responsible for full payment of tuition.
2. No refunds or credits will be issued for withdrawals or program changes (including weeks attending) after March 1, 2012.
3. Enrolling for additional weeks is always subject to availability. Any weeks added after Camp starts are at the highest weekly rate of the year.
4. There are no refunds or credits due to illness, absence, suspension or emergency closing.
5. Camp reserves the right to terminate this agreement at any time and for any reason with no penalty.
6. All payments are due in full per the payment schedule included on the front of this form. All late payments are subject to a late charge of 1 1/2% per month. Campers with an open tuition balance may not attend Camp and no refunds or credits will be issued. There is a \$35 charge for all returned checks.
7. All Campers must submit a Medical Examination Form signed by a physician and a Camper Medical History Form within 60 days from enrollment. No Camper will be permitted to attend Camp without these forms and no refunds or credits will be issued.
8. Permission is granted for my child to participate in all Camp activities including trips outside of Camp for grades 4-9.
9. Camp reserves the right, in its sole discretion, to suspend or dismiss any Camper if his or her conduct is detrimental to the well being of the Camp or of any other Camper(s) and no refunds or credits will be issued.
10. Camp may photograph and video my child and use these images for brochures, websites, promotional, and/or advertising purposes.
11. Camper's family contact information on group lists and other similar formats may be shared with other Camp families solely for the personal use of such families.
12. Camp reserves the right to add a fuel surcharge of \$10/Camper/week on March 15, 2012 if the cost of regular unleaded gasoline in Long Valley is above \$4.49 per gallon (only applies to Campers using bus transportation).
13. All Campers must be fully toilet trained prior to attending Camp.
14. All dates are subject to change when school closings are finalized.
15. Any dispute concerning, relating, or referring to this agreement, any representation concerning my child's camping experience, or the camping experience itself shall be resolved exclusively by binding arbitration in Morris County, NJ according to the then existing commercial rules of the American Arbitration Association and the substantive laws of NJ.
